

The school shall not be transferred from the one place to another or transfer the same to any person for minimum period of 5 years. There is only one time chance to transfer. If in case of transfer/handing over and establishing in new places to obtain the new registration and recognition from the concerned department.
6. As per the Karnataka State Organisation Registration Act 21, 1960 Sl. No. 9, 1957 Order 13 to maintain the Auditing report previous year (Upto March 31) and produce the documents to the Registrar and obtain the permission of with respect to the executive committee members list from the concerned authority and received the acknowledgement and list of permission shall be reserved.
7. Education Act 1983 Government Official Memorandum ED 131 vividha 98 dated 04-11-99 recognition rule 1999 sec. 3 sub sec. 2 and the Director, High Education Circular No. C(8)(4)(7)sha.shi.a.ni.a/01/02-03 dated 13-12-02 to deposit the fixed deposit as per the rate and renewed by the Administrative Institutions Secretary and Official authority jointly from time to time.
8. To strictly follow Government order No. ED 44 SLB 2007 dated 03-09-2007 Appendix 3 Check list having all the information and documents and to strictly follow the rules and regulation.
9. Government order No. ED 74 vividha 2004 Bangalore dated 14-08-2006 maintain the Auditing report and maintain the documents.
10. To appoint the qualified teachers as per the rule of department if appointed without qualified teachers immediately remove them and appoint a qualified teachers.
11. To maintain the service register as and when by entering and declared as per the Government order No. ED 104 SEP 2005 dated 12-01-2006 to the appointing teaching / non teaching staff in the school.

16. The Physical Punishment shall not given to School children.
17. To advertise in front of the school to prohibition of selling of tobacco within the jurisdiction of 100 meters.
18. The running school must be registered and register as per the Educational Act 1983.
19. While maintaining the school bus follow the rules of the Transport Department.



On 22-02-2015 the court passed an order and within 20-05-2015 for permission and The Commissioner, Department of Public Instructions Bangalore order No. 10-04-2015 and Memorandum dated 16-05-2015 1 to 5 the standard registered under Kannada medium school to English medium school given representation to the Commissioner and in which school permitted by the Commissioner the colum No.(9) rules not applicable for that school.
23. To follow all the Karnataka Education Instititon rule 2018 sec. 5A and sec. 7 schedule and to take appropriate safety to the children.
24. The fee details shall be affixed on the notice board. And to teach the lesson in Kannada First and Second language.
25. To maintain the minimum attendance as per the Karnataka educational institution recognition rules 1999 Government order No. ED 131 vividha 98 dated 04-11-99 sec. 4(k). Present year Admission-attenadnce will be exempted and follow the Department rules for future academic year to maintain the admission/attendance as per the order.
26. Follow all the rules and regulations of Karnataka Educational Act. Do not produce the false information if not the recognition will be cancelled. Registration and Recognition rules must be followed strictly.
